Scope of NIDRR Mandate

Cross-disability Work

- Physical and mobility impairments;
- Sensory impairments;
- Cognitive impairments; and
- Psychiatric disability.

Cross-lifespan Work

- Children and youths;
- Working-age adults; and
- Older individuals, including those "aging with" lifelong and early-onset disabilities, and those "aging into" disability.

Strategic Goals From NIDRR's 2005-09 Long-range Plan

Research & Development

To advance knowledge through research and related activities to improve policy and practice and to enhance the lives of individuals with disabilities.

Capacity Building

To advance knowledge through capacity-building to conduct high quality and relevant disability and rehabilitation research and to guide decisionmakers.

Knowledge Translation

To advance knowledge through the use of scientifically-based research, technologies and applications to change policy, to improve practice and to enhance the lives of individuals with disabilities.

- Employment Research;
- Participation and Community Living Research;
- Health and Function Research;
- Technology for Access and Function Research; and
- Disability Demographics Research.






The NIDRR Logic Model

NIDRR Logic Model: Planning for Research Outcomes

Situation: Significant gaps exist in knowledge, skills, policy, and practice and system capacity that prevent people with disabilities from having equal access to opportunities for employment, health and function, and participation.



Contextual Factors: Variable funding; scientific and technological advancements; societal attitudes; economic conditions; changing public policies; coordination and cooperation with other government entities.

NIDRR's New Plan

- Builds upon the previous plan;
- ⇒Includes the logic model; and
- Clarifies and focuses the previous plan.



Long-range Plan Focus

Given that NIDRR wants to build on its strong history of accomplishments and to answer the call for increased impact on its activities, the focus of the Long-range Plan will be to:

- Propose research tied to improving outcomes in employment of people with disabilities, and [long-term outcome]
- Link NIDRR's research and development, capacity building and knowledge translation to the elimination of employment barriers. [intermediate outcome]
- Investigate a broad range of needs such as health and function, rehabilitation, technology, participation, policy, and workplace and workforce issues. [short-term outcome]
