- NIRS testing completed. You may begin data entry for the current program year.
- NIRS now reflects both Program Year (PY) and Fiscal Year (FY). PY22=FY23

FY 2023 = Program Year 2022 | 07/01/2022 - 06/30/2023 ---AAA-Test Center, UCEDD/LEND

- Paper Forms and other resources should be available by August 15
- User Guide, Data Dictionary will be updated in September

#### Demonstration – cont.

- Trainee dataset > trainee year record:
  - Long-term trainee: criteria for enrollment
    - Long term-trainees (LTT) complete 300+ hours of didactic and experiential training that includes clinical and leadership requirements listed in the NOFO.
    - Individuals whose entire training program is less than 40 hours are captured in the Short term Trainee dataset. Undergraduate long-term trainees are generally not allowable. Please contact your project officer before enrolling undergraduate long-term trainees into your program. LEND programs should refer to the NOFO for exceptions.

  - Part 5: Expanding the Public Health Workforce within the Disability Network Program Measures





# Reminders: MCHB Programs

- If you are participating in the export, please wait to fill out anything in the EHB.
  - The export is planned for August, and your NIRS data is uploaded into the EHB in early September.
  - MCHB will ensure all grantees participating in the export have performance reports in an "In Progress" status in the EHB before the import begins.
  - After the import is completed, MCHB will notify grantees that the data transfer is completed.
  - You should then log into the EHB, review your data, and complete additional sections of the report in EHB.





#### Reminders: UCEDDs

- Five-Year Final Closeout Report
  - UCEDDs whose core grant cycle ended in 2022: your five-year final report is due September 29
    - If a no-cost extension is received, the final 5-year closeout report will be due 90 days from new end date
    - Inform <a href="mirs@aucd.org">nirs@aucd.org</a> if a no-cost extension is granted
    - NIRS will be updated with a feature to differentiate activities documented in a single program year that require reporting in different 5-year cycles
    - If UCEDDs do not engage in activities related to optional core function, enter this impact statement: "UCEDD does not engage in activities related to this optional core function."
